COMFILING a family tree used to be difficult and time-consuming. Records in Victoria had been poorly organised and sometimes impossible to find. But from December 11, tracing family roots will be a relatively simple process. A new index to Victorian births, deaths, and marriages dating from the beginnings of the colony of Port Phillip and finishing in 1888 has just been completed. The new index will be available to the public at the LaTrobe section of the State Library.

LETTERS OF REPLY TO STATE CONFERENCE RESOLUTIONS 1990.

Dear Mrs. Dempster,

Thank you for your letter of 14 June, 1990 suggesting that full birth and death certificates should be provided at the time of the registration instead of the extracts.

Births are registered to provide evidence of citizenship, age and parentage for the Victorian born and for statistical purposes. Deaths are registered for probate and statistical purposes. Amendments to the Registration of Births, Deaths and Marriages Act in 1959 removed the requirement for informants to personally tend to register a birth or a death and enabled registration by post. The practice of sending an extract is to notify the informant that the registration has been completed. The fees are set to recover the costs. There is little profit margin in them.

Recently, a number of representations similar to yours have been received. A review of the practice of extracts and full certificates has been commissioned. It is expected that new procedures more appropriate to the needs of the community will be instituted.

ISLE OF THE DEAD - TASMANIA.

BURIAL GROUND FOR FORT ARTHUR.

The island off Point Puer was originally named Opossum Island, but during most of the convict period it was called "Dead Island". It was the Settlements burial place - for both convict and free. From 1831 to 1877 the island was the final resting place for nearly 2,000 people. Barely an acre in area, it provided graves for 1769 convicts, including Point Fuer teenagers, and 180 officials, soldiers, seamen and their families.

The free people were buried in the higher ground and many of their headstones are still standing, although some are difficult to read due to deterioration of the poor quality sandstone which was used. Convicts were buried in unmarked multiple graves, their bodies wrapped in sailcloth, covered with a layer of quicklime and a layer of soil and the grave left ready for the next burial. These graves usually held six or seven bodies and were dug as close together as possible. Convicts were not permitted to have headstones, but in later years there have been nine erected. A burial service was given for all persons.

A resident grave-digger kept graves ready for the next recipient. Once a week a boat sailed the 1 km to the island to take him fresh food supplies and take him ashore that he may attend church.
