Club Championships

Conditions of Entry

The Club Championships for 2003 will be held on the following dates and times:

- **12th October beginning 10 am—All Competitions**
- **18th October beginning 1 pm—Junior and Senior Competition semi-finals and finals**
- **19th October if required beginning 1 pm—Junior and Senior Competition finals**

Matches can be arranged by both parties prior to the allocated times above.

All players are expected to be at the courts at the times given above. If a player is not available to play within 10 minutes of this time, the match may be forfeited (at the discretion of the tournament organisers).

All junior matches will be first to 8 games with a tiebreaker at 7 all, except for the A and B finals which will be the best of three sets (6 all tiebreaker).

All senior matches will be the best of three sets with a 6 all tiebreaker.

All veteran matches will be the first to 8 games with a tiebreaker at 7 all.

A \$5 entry fee is payable for all entrants in the Senior and/or Veterans events. This fee is not applicable to the Junior tournament which is free of charge. The entry fee is a flat rate which entitles play in any of the senior or veteran events.

Each event must have at least 4 entrants for it to be held.

Competition Eligibility:

All players must have a current Tullamarine Tennis Club membership and have paid the full entry fee (if applicable).

Junior player eligibility is determined by the grade of play in the NSJTA. The A & B competition is open to all junior players. The C & D competition is open to all junior players who are currently in either C or D grade junior competition only.

The veterans competition is open to all players over the age of 35 at the beginning of the tournament (6/10/2003).

Repercharge Competition:

All first round losers of the open tournament (singles, doubles and mixed) will be automatically entered into the repercharge competition, if the open event has at least 8 entrants.
