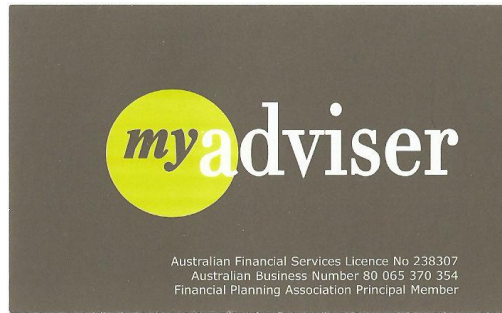
IMPORTANT

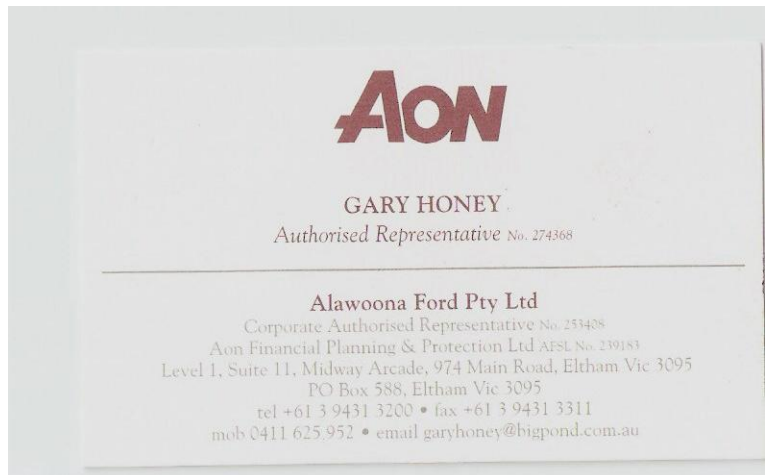
